



2022 Seasonal Campsite Payment Schedule & Refund Policy

Seasonal Campsite Refund Policy:

This policy is intended to maintain good relations with both current and prospective patrons. Our Conservation Area will adhere to this policy to ensure consistency when providing refunds.

Prior to being accepted as a seasonal camper for the current camping season every returning and new seasonal camper is required to provide a seasonal campsite application, pay a \$200 non-refundable site deposit and provided all required documentation including: camp unit ownership, photo of camp unit and proof of third-party liability insurance in the amount of \$2,000,000.00 with the Authority named on the policy,

When accepted seasonal campers make their full campsite payment and complete a Campsite License Agreement at the beginning of the operating season, they are committing to becoming a "seasonal" camper. These campers then receive a competitive reduced rate to camp on a campsite within our Conservation Area for a temporary seasonal basis.

Rather than implementing a complete "zero refund" policy, once seasonal payment is processed we will not offer any refunds after July 26th.

During the first eight (8) weeks of the season, campers may request a refund of their seasonal camping fees (minus the daily camping fee for each day since the season began). The Refund Comparison Options chart shows the refund available during this time. After July 26th, there will be no seasonal camping fee refunds under any circumstance.

NO refunds are available for other paid seasonal camping services or for additional vehicle passes sold.

Please note that the refund policy does not apply to site evictions. NO REFUNDS are available at any time as a result of a seasonal campsite eviction.

New Campers:

We are offering a reduced fee to new campers joining us on or after July 6, 2022 based on site availability. The Refund Comparison Options chart outlines the reduced seasonal fee schedule.

We hope these changes help us to better serve both new and prospective seasonal campers at our Conservation Area. Camp Unit Storage Arrangements:

Campers planning to store their camping unit on the campsite for the winter storage season period must be approved by the Park Superintendent. Campers storing their camp unit will also be required to pay a non-refundable site deposit for the following camping season to hold a campsite.
