- 4. Refund Policy Should a proponent withdraw an application; Maitland Conservation reserves the right to charge a processing fee to cover the costs associated with staff review time. The fee will be determined by Maitland Conservation on a case-by-case basis.
- 5. In cases where technical review fees exceed the application fee, the applicant is to be charged the next highest application fee until the technical review fee is covered. Alternatively, at the discretion of the Authority, the applicant may be charged the application fee and the technical review fees.
