

Maitland Valley Conservation Authority (MVCA)

2024 Hunting Permit Application

MVCA HUNTING POLICIES

Hunting on MVCA lands requires individuals to obtain a permit to hunt on lands owned by the MVCA that are designated for hunting. Permits are valid for the calendar year of the approved application and provide access to all MVCA properties where hunting is permitted.

For 2024, an administrative fee payment applies. An applicant who resides or owns property in a member municipality is considered a Resident. All other applicants are considered Non-Resident. Member Municipalities include:

Hunters must have \$2 million personal liability insurance (Ontario Federation of Anglers and Hunters or similar insurance policy) and provide proof of insurance in this application.

Hunters must have all appropriate and valid hunting licences and permits (Federal, Provincial, and Municipal). Your Outdoors card MUST be valid until December 31st of the year you are applying for.

All federal and provincial regulations, seasonal and species restrictions, and conservation area rules must be followed.

All hunters must have valid hunting licences and a MVCA hunting permit in their possession when hunting on Conservation Authority lands.

Applicants must agree to the terms, conditions, and liability waiver for a permit to be approved.

CONSERVATION AREA RULES, REGULATIONS, AND POLICIES

Please refer to Ontario Regulation 688/21 for Conservation Areas Regulations which come into effect April 1st, 2024. https://www.ontario.ca/laws/regulation/210688

- Hunting areas within designated conservation areas cannot be "claimed" or "held" by anyone.
- All hunting stands or blinds **must** be portable and removed when not occupied by the owner. Spikes, nails or any material that penetrates into a tree is prohibited and cannot be used. Stands or blinds not in compliance will be removed and disposed of by Authority staff.
- Destruction of plant material is prohibited including the cutting of branches or shrubs.



- No unauthorized motor vehicles are permitted on Conservation Area lands at any time including ATVs, UTVs, Motorcycles, Etc.
- No fires or camping permitted on lands designated open to hunting.

ADDITIONAL TERMS, CONDITIONS AND WAIVER OF LIABILITY

The MVCA has authorized hunting as a permitted activity on designated MVCA lands with the purchase of an MVCA Hunting Permit. A map of designated lands for hunting are attached to this permit application and available online at www.mvca.on.ca

By completing and signing this Hunting Permit Application, the applicant agrees to the following:

- I agree to follow all MVCA hunting policies, conservation area rules, regulations, and policies, as well as obey all provincial, federal, municipal laws pertaining to hunting, and use of MVCA lands.
- I acknowledge that MVCA lands are multi-purpose for everyone to enjoy and am aware that other users may be present on the property. I will hunt in a safe manner and exercise extreme caution to ensure the safety of all users.
- The Hunting Permit is non-transferable and is for a single applicant only. Apprentice hunters who are 12-14 years old and accompanied by a MVCA Hunting Permit holder are not required to obtain their own MVCA Hunting permit.
- Applicants must carry the MVCA Hunting permit and a form of government issued photo id and present both to: MNR Conservation Officer(s); OPP Officer(s) or any employee or agent of the MVCA when requested as proof of identification and permit.
- Applicants will ensure they have valid public liability insurance while Hunting on MVCA lands and will renew any policy that expires during the calendar year as a condition of this permit.
- The issuance of MVCA Hunting permits is performed on a first come, first served basis.
- The MVCA reserves the right to limit the number of permits issued, suspend any and all hunting activities for any reason including, but not limited to: allowing staff and contractors to work safely on the properties, allowing forest management activities to occur, for the safety of the public, or for the preservation of wildlife.
- Any person caught in violation of the conditions of this Permit may result in charges being laid, the suspension of privileges to hunt for the rest of that calendar year and may result in denial of subsequent years hunting permit approval.
- The Applicant defends, indemnifies and saves harmless the MVCA, its officers, members, directors, and employees, from and against any and all liabilities, claims, fines, actions, or proceedings of any kind and all losses, costs, expense, judgement or any damage to property or injury to persons including death arising out of the use by the Applicant, of the lands and premises or other matters to which this agreement pertains, together with all legal expenses and costs incurred by the Applicant in defending any legal action pertaining to the above.

A yearly hunting permit must be purchased from the Authority before hunting on Conservation Authority lands. All hunting on Authority lands must be undertaken in conjunction with the hunting regulations administered by the: -Ontario Ministry of Natural Resources and Forestry

-Environment and Climate Change Canada (Migratory Birds)

Unauthorized ATVs and motorized vehicles are not permitted on Conservation Authority lands at any time. Temporary tree stands are permitted, but these stands/ladders shall not be attached to a tree by any method that penetrates the tree and must be removed when not in use. Stands will be removed that are not in compliance.
